BENEFICIARIES WERE CAREFULLY SELECTED TO RECEIVE SOLAR COOKER TRAINING AND OTHER FUEL-EFFICIENT COOKING TECHNOLOGIES. FIRST PRIORITY WAS GIVEN TO ELDERLY GRANDPARENTS RAISING ORPHANED CHILDREN, WIDOWS, AND WIDOWERS. IN WESTERN KENYA, 4,783 HOUSEHOLD BENEFITED FROM RECEIVING SOLAR COOKERS, IMPROVED COOKSTOVES, RETAINED-HEAT COOKERS, WATER PASTEURIZATION INDICATORS (WAPIS), AND SAFE WATER JARS IN WHICH TO STORE PASTEURIZED WATER.
